Hawaii Chapter Recognized at National AGA Professional Development Conference At the annual Professional Development Conference (PDC) held in San Diego from July 28 – August 2, 2012, the Hawaii Chapter received three awards for the 2011 – 2012 Program Year. The Chapter earned enough points to qualify for the Gold Level Status in the Chapter Recognition Program. In addition, we received an Education Award for the Hawaii 16th Biennial AGA/ASMC Government Professional Development Conference that was held in August 2011 at the Sheraton Waikiki Hotel.

We also received special recognition for achieving the Highest Overall Growth for the year in Group B (150-299 members). April Luncheon Program

Our April Luncheon Meeting was held on April 20, 2012, at The Coronet Room at the Plaza Club in downtown Honolulu. The featured speaker was Derek Kim, Senior U.S. Probation Officer, Financial Specialist, United States Probation, District of Hawaii. He has been with U.S. Probation for 13 years and supervises many of the offenders convicted of "white collar" offenses such as ponzi schemes, bank fraud, embezzlement, tax evasion, and aggravated identify theft. Many of these felons were chief financial officers, accountants, loan officers, and managers of government and private agencies.

Mr. Kim said that often, these criminals were very charming, very intelligent, and were great salesmen. They were sociopaths who gained positions of trust where they subsequently exploited poor internal controls. They rationalized their crime and felt they were "owed" the money they stole. After serving prison sentences, they don't think about paying back their victims and making up for their crime. Instead, they think about how they can get back what they lost, and how to get even more.

His job is often interesting as it is not always a desk job. While conducting surveillance, he once pretended to be a homeless person, begging for money. He also pretended to be a construction worker, stenciling the road and taking pictures.

He contrasted the crime and punishment of his probationers against the drug dealer. The drug dealer can be sentenced to five years for possessing the equivalent of five sugar packets of drugs. He often feels remorse and has physical and mental health issues. On the other hand, the white-collar criminal, who usually has a shorter sentence, often has more victims, has stolen more money - sometimes victims' life savings - and doesn't always see the actual impact of his crime on those he ripped off. Mr. Kim felt the white collar criminal was more culpable but society and/or the law does not at this time.

Audio Conferences

The Hawaii Chapter continues to offer free CPEs for audio conferences sponsored by the AGA National Office. The Chapter picks up the tab for the conference fee and allows unlimited dial-ins. For the past several months, the following audio conferences were offered.

On March 21, 2012, the topic was: A Systems Approach to Implementing Performance-Based Management and Budgeting for two CPEs. The presentation focused on lessons learned and best practices in implementing performance-based management and budgeting. Discussions included how to define performance expectations and goals, identifying appropriate resources to achieve the goals, designing systems to measure achievements, and using performance reports and measures to support decision-making. The speakers were Stephen L. Morgan, CEO, EGAPP, Inc, and former city auditor of Austin, Texas; and Sam McCall, PH.D., MPA, CGFM, AGA Past National President, and auditor of Tallahassee, Florida.

On May 23, 2012, the Hawaii Chapter sponsored an audio conference on "Ethical Decision-Making for Auditors". It was presented by Alan Z. Goodman, a Master Trainer in Ethical Fitness Seminars for the renowned Institute for Global Ethics. The material for the course was based on the works of the late, Dr. Rushworth M. Kidder, who wrote "How Good People Make Tough Choices" and "Moral Courage". The presentation discussed ethical dilemmas and tools to analyze and resolve dilemmas. Some of the topics included: compliance versus ethics; codes of ethics such as the cowboy code or the code of the warrior; independence, right vs. right; resolution principles; and what makes moral courage so challenging? This was a very popular topic.

Ronald McDonald House

Hawaii Chapter members made dinner and socialized with the residents of the Ronald McDonald House at 1970 Judd Hillside Road located in the Manoa area on Saturday, March 31, 2012. More Accolades for City and County of Honolulu Audit Reporting

The City and County of Honolulu Auditor's Office was featured in the April 2012 issue of the AGA National Newsletter. In an article titled "Honolulu Official Describes Lessons Learned, Plans for Future SEA Reports", Susan Hall, Project Manager and Deputy City Auditor, described their collaborative efforts to work with the various City departments to produce their award-winning Service Efforts and Accomplishments (SEA) Report. She also said they benefitted greatly from City Auditor Edwin Young's assistance and experience in producing a similar report for the city of Palo Alto, California. Honolulu also won the 2011 Knighton Silver Award from the Association of Local Government Auditors (ALGA) for their audit report on ambulance services. According to the ALGA write-up, "the report was well-written, had good visuals, and demonstrated an innovative approach...The auditors drew sound conclusions, and the recommendations were clear and specific."

Golden Anniversary

The AGA Hawaii Chapter is 50 years old! We can celebrate our Golden Anniversary! We received a chapter charter in 1962 but didn't incorporate until 1976. We became the 41st AGA chapter and Ken Doolin was the first president.

Conference News

The Government Technology and Fraud Conference (GTFC) was not held this year. Due to the economic downturn and the difficulty of finding Federal Government speakers because of restrictions on conferences and travel, we were unable to secure \$10,000 to \$20,000 in sponsorship fees. It was unlikely that we would be able to recover most of the costs of holding the conference.

There is still interest in holding the Government Professional Development Conference (GPDC) in 2013. At present, we're awaiting a proposal from Sheraton Waikiki Hotel. In addition, the Education Committee is considering sponsoring one-half or one day educational conferences.

Scholarship

The Hawaii Chapter set up a \$50,000 perpetual annuity scholarship fund with the UH Foundation a few years ago. Scholarships were to be presented each year based on the earnings of the fund, however, because of the stock market performance, the fund, which is managed by the UH Foundation had fallen below the \$50,000 principal in recent years. This past year, we added additional funds to bring the scholarship fund back up to the \$50,000 principal and added a one-time contribution to award a scholarship for \$1,000. The scholarship was presented to Lisa Sugai. Congratulations to her!
