AG Doug Chin graduated from Stanford University and received his law degree from the University of Hawaii. Prior to becoming attorney general, Chin was the managing director of the City and County of Honolulu from 2010 to 2013, and a Honolulu prosecutor for 13 years, during which he tried nearly 50 jury trials. In private practice, Chin was a law partner and eventual managing partner at Carlsmith Ball in Honolulu. Chin has also

been a board member for the American Judicature Society since 2007, during which he has served on several task forces related to courts systems and justice.

Sectional Leadership Meeting (SLM) at Kansas City, Missouri on May 15, 2015

Attending AGA's Sectional Leadership Meeting, SLM, in Kansas City, Missouri for the second year in a row was a charm. Like last year, much information was presented to assist chapter leaders in Section 3 (Northwest, West Coast and the Pacific Rim) more successfully perform their responsibilities and duties.

At the SLM, Executive Director **Ann Ebberts** reported that AGA is developing new marketing materials, refreshing the national website, revitalizing the organization, bringing in more young members, acquiring a new email service provider, and focusing on educational programs, courses, events and webinars including free CPE. She encouraged us to think broadly about who can be a member, considering other professionals (not just accountants and auditors), stay relevant in the marketplace, focus on issues impacting our members such as the human capital crisis, internal controls, the DATA Act (Digital Accountability and Transparency Act of 2014, making information on federal expenditures more easily accessible and transparent), and bring events and educational opportunities to the local chapter. Finally, she reported that the National Board of Directors will be voting on a \$10 dues increase at July's Professional Development Training (PDT) in Nashville, Tennessee.

The theme for National President-Elect **John Homan** is "Celebrating the Government Workforce" for fiscal year 2015-2016. Although frequently overlooked by the media for their dedication, skill, integrity, competence and efficiency, the government workforce delivers some of the most innovative solutions at their work sites. At the same time, workers at all levels of government are facing unprecedented challenges. During his tenure, he would like to help improve morale and media perception of the government workforce. Other areas of focus will be the early career members, the future leaders in financial management and AGA, international expansion, and the Certified Government Financial Manager (CGFM) program, the preferred designation for federal GS-12 positions and higher.

AGA Field Representative and Past National President **Bobby Derrick** made a number of recommendations: (1) Develop relationships. At the maximum, we are separated by six degrees (steps) from everyone else in the world. By being introduced to someone, the power of transfer comes into play. (2) Successful leaders delegate, delegate, delegate! (3) Personal invitations are crucial for member involvement in chapter activities and leadership positions. In addition, ideas were offered on the following topics: Establishing a student chapter, having successful chapter executive meetings, general membership meetings and community service projects, and enhancing the chapter's long-term viability.

SLM Meeting, continued

Susan Fritzlen, Deputy Executive Director and Chief Operating Officer, suggested posting chapter seminars on the events calendar of AGA's national website, and having a career section on chapter websites.

Jill Murphy, Membership Manager, reported that five hotel scholarships were awarded to Young Professionals for July's PDT in Nashville. Plans are underway to double the number of such scholarships for next year's PDT. Similarly, accounting students will be granted scholarships to attend National Leadership Training conferences.

Other breakout sessions included the following topics: Endowments/scholarships, education, chapter administration, membership and chapter leadership.


